Buyer is responsible for all costs to de-install defective products and re-install replacement or repaired products and ARLEE LIGHTING shall not be liable for labor for any consequential or incidental loss or damage, including any labor & expense costs or other costs related to the replacement or repair of the above-mentioned products. The warranty is not applicable to any products subjected to abnormal stresses and operating conditions. This Warranty assumes that the Products will be operated for an average of eight (8) hours per day. Operation of the Products in excess of 8 hours per day will shorten the Warranty coverage period to a maximum of 17,500 operating hours or 2 years whichever occurs first.
